Age Residential Facilities – PPE Ordering information

The MoH sent communications to all ARC facilities in October 2020 regarding the new process for ordering PPE as follow:

Kia ora koutou

During the response to COVID-19 you may have been receiving Personal Protective Equipment (PPE) from your local DHB. In some cases, you may have ordered PPE directly from the Ministry of Health via the online portal. This was done to ensure you received enough PPE for your facility to respond to COVID-19.

The Ministry is now enabling all aged residential care facilities to set up an account to order PPE directly from the Ministry through Healthcare Logistics (HCL). If in the future we move to Alert Levels 2, 3, or 4, you will be able to order PPE in line with the principles of supply outlined on the Ministry website. This will allow you to have better control over your orders and order quantities proportionate to demand.

This new ordering system will be in place from start of December 2020. There are few things you need to know first:

- the Ministry has set up an online portal that you will be able to log into and order the PPE you require some of you will already have access to this portal
- as Alert Levels change, so will your PPE requirements we suggest you regularly check the Ministry's <u>principles of supply</u> and Infection Prevention and Control Risk assessment information to ensure you understand what PPE can be provided
- under the new system orders will close at 5pm on a Monday and will be dispatched within 48 hours (usually on the Wednesday).
- the current Ministry's <u>principles of supply</u> indicate the Ministry will continue to supply PPE to you at no cost in Alert Levels 2, 3, or 4, however you should be aware that this is not a long term arrangement
- you do not have to use the online portal and order PPE from the Ministry you are welcome to make alternative arrangements
- you will need to set up an account to place future orders and receive PPE
- to open an account and gain access to the online portal you will need to run through the standard credit process, however we are not currently planning to charge for PPE
- to order from the online portal you will first need to complete the attached credit application form and email to Healthcare Logistics at mohppeordering@prnzl.co.nz

We have added RATs to the list of products available on the PPE portal for Aged Residential Care facilities.

We expect your orders for RATs to be reasonable and in line with data and information already provided to the Ministry of Health to support your previous orders and engagement throughout COVID. You will need to work through your use cases and provide this to the Ministry of Health to confirm allocations.

Initially, we will allow for 300 eaches of RATs to be supplied to Northern region Aged Residential Care settings, and 100 RATs in all other regions as an initial injection of RATs while operational planning is completed.
