The Health System in Aotearoa is entering a period of transformation as we implement the Pae Ora/Healthy Futures vision of a reformed system where people live longer in good health, have improved quality of life, and there is equity between all groups.

We want to build a healthcare system that works collectively and cohesively around a shared set of values and a culture that enables everyone to bring their best to work and feel proud when they go home to their whānau, friends and community. The reforms are expected to achieve five system shifts. These are:

- 1. The health system will reinforce Te Tiriti principles and obligations
- 2. All people will be able to access a comprehensive range of support in their local communities to help them stay well
- 3. Everyone will have equal access to high quality emergency and specialist care when they need it
- 4. Digital services will provide more people the care they need in their homes and communities
- 5. Health and care workers will be valued and well-trained for the future health system

#### Te Mauri o Rongo – The New Zealand Health Charter (to be confirmed)

Te Mauri o Rongo is currently being finalised – this section provides an overview of anticipated content. In order to guide the culture, values, and behaviour expected of the health sector, Health New Te Mauri o Rongo provides common values, principles and behaviours through four Pou, to guide health entities and their workers, enabling a cultural transformation of the health sector. Te Mauri o Rongo fundamentally upholds a key system shift of the New Zealand health reforms to reinforce and embrace Te Tiriti and our obligations to it.

The pou are a platform and a foundation to empower a culture transformation, every person is guided to align themselves to the pou and enact the values and behaviours that the pou represent. Employers and employees are expected to uphold Te Mauri o Rongo in their work and environments as part of our commitment to achieving Pae Ora (healthy futures) for all.

It is fundamental that the four Pou of Te Mauri o Rongo are upheld by the health entities and their workforce.

#### **Social Worker**

#### **About the role**

The Rural Health Social Work role at Lakes District Hospital encompasses General Inpatient, ED, Maternity, Outpatients and Community including ACC / MSD / NASCs, and is an all age service currently managed by one FTE. The role has grown over the past two years with a continually expanding population with more complex health factors including wide ranging social issues. There is also a better awareness of Health Social Work overall which leads to more Community referrals. Social Work is integral to the MDT processes across Secondary and Primary Health sectors and as an Interagency approach across the broad spectrum of Community Services when working alongside clients.

The role is very busy and varied day to day with a need to understand health related issues and simply convey in client discussions to support health care planning. The ability to flex and adapt is essential to support the needs of Inpatient Services for patient journey and bed flow management for timely discharge planning and access to relevant community services. Similarly, all new community referrals are reviewed and re-prioritised, as necessary until a Psychosocial Assessment occurs and a plan developed.

This new Social Work role is an exciting opportunity to experience Rural Health with colleagues who are dedicated to the Wakatipu Basin community and advocate for clients to have easier access to Tertiary Health in Southland and Dunedin.


