Message from Chair Lyneta Russell



I feel very privileged to have the opportunity to Chair the Community Health Council and to follow in the footsteps of Karen Browne, the Chair from January 2019 until the end of January 2023. Karen was well known throughout the Southern DHB and Te Whatu Ora South/WellSouth for the knowledge and commitment that she brought to the position. Her hand over to me indicated the spread of her input across the southern primary and secondary services, and the wisdom and

knowledge on community engagement that she shared.

Since the beginning of February 2023, the Council has been very aware of some of the pressures that both Te Whatu Ora and WellSouth have been under. Workforce issues are impacting all services and most staffing groups, and this during a period of significant change within those same services. It has not been an easy time for all, and the Council extends their gratitude to all the staff for the work that they do, despite the difficulties, to ensure that our southern patients, consumers and communities continue to receive a high standard of support and care most of the time.

Often, we hear of the failings, where things have gone wrong. And while these things shouldn't happen because they impact enormously on individuals, family, whānau, and communities it is important to remember that many of these events happened some time ago. Over the past year I have been given the opportunity to see many positive

changes happening. There are numerous pieces of work being done by staff and processes put in place to reduce adverse events, to learn from when things have gone wrong, and to listen to the voice of patients, families and whānau. The Code of Expectations has given power to the voice of patients and whānau and Te Whatu Ora Southern and WellSouth are keen to involve them in projects and learning experiences.

Our group of Community Advisors participate in numerous projects across the region using their experience and their interest to have input into many aspects of the southern health and disability services. From input into the hospital rebuild to adverse events and specific service groups such as the endoscopy oversight group, community advisors help ensure that consumers have input across service design and development, implementation and review and evaluation. On behalf of the Community Health Council, I extend my thanks to this wonderful group of people who give up their time and share their knowledge and experience to benefit all of us in the southern region.

Finally, I want to extend my thanks to the support the Community Health Council is given from Hamish Brown Group Director of Operations, Te Whatu Ora Southern, and Andrew Swanson-Dodds CEO WellSouth. Not all Consumer Councils across NZ share the same level of support and so we don't take this support lightly. Our collaboration is what will help ensure effective partnerships and communication pathways for our Southern patients, whānau and communities.

Who We Are

The Community Health Council is an advisory council for Te Whatu Ora Southern and WellSouth Primary Health Network (hospital and community health services including GPs) and enables a stronger community, whanau and patient voice to be heard in decision-making across the Southern region The CHC has a rotational membership of up to 12 members, with members representing different areas of health journey experience or interest, as well as geographical representation from across the district. As well as the CHC members on the Council, there is a database of over 80 Consumer Advisors, who may be selected to work on any project within their indicated health interests or experience. See Appendix 2.

Our communities, whānau and patients are active partners in the Southern Health System design, planning and decision-making to achieve improved health processes and outcomes.

Summary of the Year 2022/2023

Guests to CHC

To enable the Community Health Council to perform its function as an advisory council, guests are invited to monthly meetings to present their work and receive advice on how to progress this. In the last year, the below guests attended meetings.

July

Miranda Buhler - Carpal Tunnel Programme

Miranda provided an update on this pilot project which had been well-received - trial of telehealth to increase access to the service. Consumers felt their needs were being met in this way.

Michelle Archer and Sara Evans - Maternity Quality and Safety **Programme Governance Group**

Overview provided to CHC of this group, which has just recruited new consumer advisors. Looking at how they can provide equitable service across the district.

August

• Stuart Barson and Andrew Lesperance - Localities and how CHC can contribute to this work.

Feedback sought from members about how they felt CHC could contribute to localities work, aimed at ensuring equitable service for all communities, as determined by those communities.

Emma McDonough - Rural hospitals - an update from the new Service Manager

Working on a rural health strategy but needing to encompass that each has different operating models. Needs Assessment has been published, focus subsequently is whether those needs are being met.

September

• Dot Brown - Access and Choice Programme

Update on programme - Over half of enrolled population have access, but not yet in half the practices. Also working to develop a collaborative dashboard that informs practice.

Sam Murray - Signage and Poster Policy

Recognition that organisation needs a policy on this as Covid showed up how much inconsistency there is in this space. Sought feedback on what was needed from the consumer perspective.

October

Hywel Lloyd - Clinical Governance

Developing a clinical governance policy which will eventually produce a framework for all departments, including rural and primary health to follow.

Megan Boivin - Patient Flow

Aiming to improve communication around discharge so that patients and whānau are more prepared, seeking feedback on what considerations needed to be taken into account from consumer perspective.

November

Patrick Manning and Emily Gill - Clinical Transformation Group Consideration of relationship between CHC and Clinical Transformation Group for New Dunedin Hospital given that neither are in governance roles. Further feedback to be provided from members.

Simon Donlevy and Craig Ashton - Endoscopy Oversight Group **Update**

Performance now in line with expected standards for the endoscopy service.

December

Stuart Barson - Localities Update

Still no agreed policy beyond the current 12 locality prototypes. Engagement has commenced and is going well.

March

Jo Witko - The Role of Consumer Councils in the future

Sought feedback from members on the proposed National Reimbursement Policy. Advised that where things are working well, that won't be interfered with.

Michelle Panov - Community information to consumers - Allied Health

Feedback sought from council on pamphlets being provided to consumers. Advice provided to enhance accessibility and inclusivity of information being provided to consumers.

Paddy Lewis - Communications to consumers - Surgical Services and Outpatients

Proposed communications with consumers to advise of expected times on wait list, check that appointment is still required. Would like to have more correspondence that explains wait list process. To provide information for review to members.

April

Lorraine Ritchie - Patient Admission Document

Development of a new patient admission document. Feedback sought from members on content and administration of document.

Julia Cronin - Rural Health Strategy

New Rural Health Strategy being developed as part of Pae Ora. Sought feedback from members about what was important to include. Southern a particularly rural community so input was important.

Marc Haughey - Long Term Conditions

New programme development for a number of common long term conditions enabling consumers to receive care at GP and community providers in the way that makes sense for them. Focus on appropriate care planning and continuing to support selfmanagement.

May

• William Robertson - Consumer Engagement Quality Service **Marker Results**

Improvement in all three dimensions, engagement, responsiveness and experience. Reporting from now onwards will be against the new framework incorporating the Code of Expectation.

June

Renee Steel - Southern Blood and Cancer patient letter

Consumers experiencing delays in receiving first specialist appointment - preparing a letter for patients to explain this and provide support options in the interim. A member to work closely with the team to develop this.
